You are Eligible if:

- Your child is a resident of Kentucky and either a U.S. citizen or qualified legal alien.
- Your child is under 13 years of age. There is an exception for children 13 to 19 years of age if your child has a disability.
- You fit one of the following scenarios:
 - You work an average of 20 hours per week as a single parent and your income is less than childcare income limits.
 - You work an average of 40 hours per week as a couple and your income is less than childcare income limits.
 - You are a teen parent attending high school or pursuing a GED.
 - You currently participate in the SNAP Employment & Training program.
 - You are an adult who is a full-time student at a certified trade school or accredited college or university.
 - You participate in Kentucky Works activities.
 - You need childcare as a support for child protective/preventative services.
 - You are looking for employment.



<u>Commonwealth Attorney</u> prosecutes of felony crimes. They attend each Circuit Court in their judicial circuit and have a duty to prosecute all violations, by adults or juveniles, of the criminal and penal laws of Kentucky. In addition, they present evidence to the grand jury concerning criminal violations.

<u>County Attorney</u> prosecutes misdemeanor violations, by adults or juveniles, of criminal or penal laws of Kentucky that occur within the county. They also provide legal advice to the county Fiscal Court as well as county officials and officers. Their office may also collect court-ordered child support.

<u>Circuit Court</u> is Kentucky's highest trial court and has general jurisdiction in civil matters involving more than \$5,000, capital offenses and felonies, land dispute title cases and contested probate cases.

<u>Family Court</u> is a division of the Circuit Court devoted exclusively to cases involving families and children. Family Court provides one judge to hear all of a family's issues relating to divorce, child custody, adoption, termination of parental rights, domestic violence, child abuse and neglect.

<u>District Courts</u> handles juvenile matters, city and county ordinances, misdemeanors, violations, traffic offenses, probate of wills, arraignments, felony probable cause hearings, small claims involving \$2,500 or less, civil cases involving \$5,000 or less, voluntary, and involuntary mental commitments and cases relating to domestic violence and abuse.

<u>Circuit Court Clerks</u> are responsible for managing the records of Circuit and District courts, Kentucky trial courts. They have offices in all 120 Kentucky counties and are elected for six-year terms.

<u>CDWs</u> are responsible for processing public and status complaints on children under age 18 regarding status offenses and public offenses. They assist law enforcement in the custody process. Responsible for conducting preliminary investigations and interviews and developing and supervising diversion agreements.

<u>Public Defenders</u> provide legal representation appointed to those accused of crimes, who otherwise could not afford legal representation. They do work to get alternate sentencing, especially for those with substance abuse addition and or mental health conditions.

<u>Victim advocates</u> are trained to support victims of crime. They offer emotional support, victims' rights information, help in finding needed resources and assistance in filling out crime victim related forms. Our advocates frequently accompany victims and their family members through the criminal justice proceedings
